Amendment of Statement of Principles

concerning

THORACIC SPONDYLOSIS

ICD CODES: 721.2, 721.41, 722.51, 722.72, 722.92

Veterans' Entitlements Act 1986
subsection 196B(3)

The Repatriation Medical Authority amends, under subsection 196B(3) of the *Veterans' Entitlements Act 1986* (the Act), Instrument No.104 of 1995 (Statement of Principles concerning thoracic spondylosis) by:

1. inserting immediately after paragraph (e) of clause 1, the following:
 - “(ea) suffering a trauma to the relevant joint before the clinical onset of thoracic spondylosis; or”;
2. omitting paragraph (f) of clause 1 and inserting in its place in clause 1 the following:
 - “(f) suffering a trauma to the relevant joint which has resulted in permanent ligamentous instability before the clinical worsening of thoracic spondylosis; or”;
3. inserting immediately after paragraph (f) of clause 1, the following:
 - “(g) suffering a trauma to the relevant joint before the clinical worsening of thoracic spondylosis.”;
4. omitting paragraph 2 and inserting in its place the following:

- “2. Subject to clause 3 (below) at least one of the factors set out in paragraphs **1(a) to 1(g)** must be related to any service rendered by a person.”;
5. omitting paragraph 3 and inserting in its place the following:
- “3. The factors set out in paragraphs **1(f) to 1(g)** apply only where:
- (a) the person’s **thoracic spondylosis** was contracted before a period, or part of a period, of service to which the factor is related; and
 - (b) the relationship suggested between the **thoracic spondylosis** and the particular service of a person is a relationship set out in paragraph 8(1)(e), 9(1)(e), or 70(5)(d) of the Act.”;
6. omitting the definition of “thoracic spondylosis” in paragraph 4 and inserting in its place in paragraph 4, the following definition:
- “**thoracic spondylosis**' means a degenerative joint disease affecting the thoracic spine, causing local pain and stiffness, associated with degenerative changes in the thoracic spine, attracting ICD code 721.2, 721.41, 722.51, 722.72 or 722.92;”
7. inserting after the definition of “thoracic spondylosis” in paragraph 4 the following definitions:
- “**trauma to the relevant joint**' means injury caused by the force of an extraneous physical or mechanical agent that causes pain, swelling or tenderness of a joint affected by thoracic spondylosis within the 24 hours after the force has been applied;
- 'trauma to the relevant joint which has resulted in permanent ligamentous instability'** means abnormal mobility and instability of the joint due to ligamentous injury caused by the force of an extraneous physical or mechanical agent, and is characterised by the regular recurrence of episodes of pain and/or swelling of a joint affected by thoracic spondylosis.”.

The amendments made by this instrument apply to all matters to which Instrument No.104 of 1995 and section 120B of the Act apply.
